**Help**, a free step-by-step program that will help you complete your state and federal taxes online and uncover applicable tax credits.

Starting January 14th, members can access **Just File It! We'll Help** directly from a link on DCFCU's homepage. The link will lead to the I-CAN E-file website, where you'll answer simple questions about your income to generate your official tax forms. You then have the option to either print and mail the completed forms or submit them

electronically over the secure site. In 2009, Michigan users of Just File It! earned a collective return of over **\$12.7 million**!
